#### **General Jonathan Vance**

General Jonathan H. (Jon) Vance was born on 3 January 1964 in Kingston, Ontario and grew up in a military family. He started uniformed life at the age of 13 as an army cadet in Lahr, Germany. General Vance joined the Canadian Armed Forces in 1982 and was commissioned as an infantry officer into The Royal Canadian Regiment in 1986 following his graduation from Royal Roads Military College (RRMC). General Vance has served in Canada, Germany and on UN Peacekeeping operations with the 1st, 2nd and 3rd Battalions, The Royal Canadian Regiment, and has commanded at all levels within the field force from platoon commander to brigade commander and in combat operations as a

Joint Task Force Commander.

His early command and staff experiences included commanding Combat Support Company and The Duke's Company in 1RCR, and serving on the VCDS strategic planning staff as a major and lieutenant-colonel. From 2001 until 2003 General Vance commanded Second Battalion, The Royal Canadian Regiment in Gagetown, New Brunswick. He commanded 1 Canadian Mechanized Brigade Group in Edmonton from 2006 to 2008 and subsequently deployed as Commander Joint Task Force Afghanistan and Task Force Kandahar in 2009 and again in 2010.

Following his tours in Afghanistan, General Vance served in Army headquarters as Chief of Staff Land Strategy and as Director of the Strategic Joint Staff in National Defence Headquarters. He completed a tour as Deputy Commander, Allied Joint Force Command Naples in July 2014 before assuming the position as Commander Canadian Joint Operations Command in September of the same year.

General Vance was promoted to his current rank and formally appointed as the Canadian Armed Forces Chief of the Defence Staff in July 2015.

General Vance is a graduate of the Canadian Forces Staff School, the UK Combined Arms Tactics Course, the Canadian Army Staff College, the Canadian Forces Command and Staff Course, the Advanced Military Studies Course and the Coalition Forces Land Component Command Course. He holds a Bachelor of Arts Degree in Military and Strategic Studies from Royal Roads Military College, and a Master of Arts Degree in War Studies from RMC. His decorations include the Order of Military Merit in the rank of Commander, the Meritorious Service Cross with bar and a Mentioned-in- Dispatches. In 2011, he was awarded the Vimy Award for his contributions to Canadian defence and security.

# COMMISSIONER OF THE ROYAL CANADIAN MOUNTED POLICE (RCMP)



#### Brenda Lucki, Commissioner

Brenda Lucki was born and raised in Edmonton, Alberta, and joined the RCMP in August 1986. During Commissioner Lucki's career, she has served in Quebec, Ontario, Manitoba, Alberta, Saskatchewan and at the RCMP Academy (Depot Division), as well as on international peacekeeping missions in the former Yugoslavia.

Her first posting was in Granby, Quebec, where she worked in federal policing, mostly in drugs and customs investigations. In 1993 and 1994, she served on the United Nations Protection Force (UNPROFOR) mission in the former Yugoslavia, overseeing criminal

investigations and monitoring the delivery of aid and health services.

In 1995, she was transferred to the RCMP's peacekeeping program in Ottawa, where she trained and selected peacekeepers for the UN missions in Haiti for a year-and-a- half. Following that role, she advanced through the non-commissioned officer ranks, first as an instructor at the RCMP Training Academy for three years, then returning to operations in Manitoba for four years as a supervisor and Acting Detachment Commander.

In 2003, she was promoted to the rank of Inspector and held the post of Traffic Services Officer for Saskatchewan. She stayed in the province for six years, holding the role of Community and Contract Policing and District Operations Officer.

In 2009, she rose to the rank of Superintendent, and became the District Commander for the Manitoba North District. In 2012, she was transferred and promoted to Chief Superintendent, and became the District Commander of a larger area in northwest Alberta.

In 2016, she was named Commanding Officer of the RCMP Academy, and on March 9, 2018, she was announced as the RCMP's 24th Commissioner.

Commissioner Lucki completed a Bachelor of Arts in psychology and sociology at the University of Alberta in 1996. She also completed the Advanced Program in Management, Leadership and Strategy at the Asper School of Business at the University of Manitoba in 2012. She is married and has two step-daughters and three grandchildren.

### **Craig Dalton**

Craig Dalton was appointed Veterans Ombudsman on November 11, 2018. Mr. Dalton was commissioned into the Royal Regiment of Canadian Artillery in 1990 and over the course of a 25-year career, had the distinct pleasure of serving alongside Canadian soldiers, sailors, airmen and airwomen, as well as whole-of- government partners, both here at home in Canada, and abroad on operations, in Cyprus, Bosnia-Herzegovina and, most recently, Afghanistan.


During his time in uniform, Mr. Dalton served in a wide variety of staff appointments and had the privilege to lead teams from the troop to formation level including command of the 2nd Regiment Royal Canadian Horse Artillery and command of 5th Canadian Division Support Group/Canadian Forces Base Gagetown.

Following his release in 2014, Mr. Dalton joined the Government of New Brunswick where he initially served as the Deputy Minister of Public Safety, with responsibility for Policing and Community Safety, Fire Services, Emergency Preparedness and Emergency Management, Corrections, Probation Services and Inspections and Enforcement.

Subsequently, he took over the role of the Deputy Minister of Social Development with responsibility for Disability Support Services, Social Services, Child and Youth Services, Affordable Housing and Homelessness, and Seniors and Long- Term Care. Most recently, Mr. Dalton served as the Deputy Minister of Family and Human Services with the Government of Prince Edward Island.

Mr. Dalton is a graduate of the Army Command and Staff College, the United States Army Command and General Staff College, and the Australian Defence College. He holds a Bachelor's Degree from the Royal Military College of Canada and holds Masters Degrees from Central Michigan University, the United States Army Command and General Staff College, and from Deakin University, Australia.

Chris McNeil was first appointed to the Veterans Review and Appeal Board as a Member in April 2015. He was appointed Chairperson in July 2018. Mr. McNeil spent more than 30 years serving with the Halifax Regional Police before retiring in 2013 as Deputy Chief. Mr. McNeil has extensive public sector leadership experience. In the course of his career, he also acted as a workplace rights coordinator and adjudicator in discipline matters. In addition to his policing career, Mr. McNeil worked as a solicitor for the Nova Scotia Department of Justice.

Mr. McNeil holds a Bachelor of Commerce from Saint Mary's University and a Law Degree from Dalhousie University.

## ARMY, NAVY, AIR FORCE VETERANS IN CANADA (ANAVETS)

#### **Background**

- Canada's oldest Veterans association (first unit formed 1840; incorporated 1917)
- 15,000 members belong to 68 units in British Columbia, Alberta, Saskatchewan, Manitoba, Ontario, Quebec, Nova Scotia and New Brunswick – one unit in United States (ANAVICUS), part of American Legion
- National Headquarters (Dominion Command) located in Ottawa; seven provincial commands
- VAC receives resolutions from ANAVETS biennially, following the Dominion Command Convention. The 2018 Dominion Command Convention was held in Saskatoon, Saskatchewan from August 11–15.

#### **Key Priorities**

- To stimulate the spirit of patriotism in Canada and promote closer unity and co- ordination within the British Commonwealth of Nations;
- To assist the British Commonwealth of Nations when occasion requires in enlisting recruits for Her Majesty's forces;

- NAVA and AVA have served Canadian Aboriginal Veteransand serving members for over 30 years
- Voting members are Aboriginal Veterans or serving members; non-voting associate members support the Association and Aboriginal Veterans
- Mission:
  - To advocate for needs and rights of Aboriginal Veterans and their families and to support Aboriginal serving members
  - o To provide community service through Aboriginal communities and youth
  - o To honour the memory of fallen Aboriginal Veterans
  - Led by an Executive and Board of Directors

- Mandate "to promote understanding, cooperation and, if possible, uniformity in recommendations, proposals, and active efforts for the welfare of ex-servicemen, disabled and otherwise, in Canada"

#### **Key Priorities**

- Pension for Life benefits fail to address the financial disparity between the
- Pension Act and the New Veterans Charter
- Ensuring that no Veteran receives less compensation than someone else with the same disability or incapacity
- Advocating for the implementation of the recommendations of the Policy Advisory Group as presented at the Stakeholder Summit in October 2016

#### **Background**

- Established February 2007

- Headquarters located in Ottawa; regional branches in the Atlantic, Quebec, Ontario, Western and Pacific regions

#### **Background**

- In existence since 1886
- 4,000 active/paying members

- VAC has partnered with RCMP for more than 60 years to administer benefits that enhance the well-being of RCMP members and Veterans
- VAC is responsible for delivering the disability pension program on behalf of the RCMP
- VAC currently has Memorandums of Understanding with RCMP to administer treatment benefits claims
- VAC, in conjunction with RCMP, implemented a Canada-wide program of transition interviews for all releasingRCMP Regular members, civilian members and Special Constables in April 2014
- RCMP members and Veterans have access to VAC/DND network of Operational Stress Injury Clinics, counselling services, VAC Assistance Service and case management
